

Registration Declaration Statement

The Registration Declaration Statement provides details of the terms and conditions that you will be agreeing to as part of your Registration onto your course at the University of Portsmouth. It also provides you with links to relevant policies, information on how we handle your personal data, sponsorship and UKVI Student Route Visa Regulations where applicable. You will be required to agree to the relevant statement each year of your studies.

You are declaring that:

1. I have read and understood the [Student Contract](#)
2. I have checked that all the details on this registration form are correct and that I have provided copies of the appropriate photographs and documents where required.
3. I understand that the University needs to collect the personal data requested about me in this form as part of the contract I am entering into with the University when I complete this registration form, to enable the University to comply with its legal obligations under the Equality Act 2010, to enable the University to carry out tasks in the public interest, and in some instances, to act in the legitimate interests of either the University or students in general. This information will be used to:
 - i) enrol me in the University and onto my course,
 - ii) to be able to help me during my time in the University,
 - iii) to inform me of opportunities made available by the University that are additional to my course, for example, research or volunteering opportunities, further courses,
 - iv) to provide recognition of my studies at the end of my course at this University, and
 - v) to contact me after I leave the University.
4. I understand that the University may need to share some of the data that I have supplied with external agencies, as listed in the Data Protection Statement for students which can be found on the University's website: <http://policies.docstore.port.ac.uk/policy-105.pdf> in order to comply with its legal obligations. I understand that if it becomes necessary to share data in any other instances not covered by this contract, the University will ask me to agree this at the time that information is collected.
5. I understand that the University only collects the data that it needs for the purposes mentioned above, and generally holds the information for up to six years after I leave the University.
6. I am also aware that the University will monitor my attendance at scheduled teaching events and my use of the University Library (either through physical registration or the use of 'swipe' cards) in line with Central/Faculty/Department Attendance and Engagement monitoring processes.
7. I understand that the University collects, uses and holds this personal data in line with the relevant data protection legislation (the General Data Protection Regulation and the Data Protection Act 2018). I am aware that further information about the data collected, why it is collected, who to contact within the University about the use of my data and the organisation to which complaints can be made if my data has not been processed properly, can be found on the University's Data Protection webpages at: <https://www.port.ac.uk/about-us/structure-and-governance/legal/data-protection-and-gdpr>
8. I am aware of my rights concerning membership of the Students' Union, which can be found at: <https://www.port.ac.uk/-/media/files/about-us/legal/union-code-of-practice>. In line with the 'legitimate interests' legal basis for processing personal data, a limited selection of personal

information is shared with the Students' Union in order that I can be registered as a member and to efficiently enable the support and communication available from the Students' Union to enhance my student experience. Should I not wish to be a member of the Students' Union, I am aware that I can contact the University's Data Protection Officer on information-matters@port.ac.uk to request that my data is not passed to the Students' Union or that it be removed from the Students' Union database if the data has already been passed to the Students' Union.

9. I agree to abide by the University of Portsmouth regulations, as they apply to my studies at the University. This includes the University's policy with regards to tuition fees, withdrawals, suspensions and refunds.

10. I agree to inform the University if my circumstances change.

11. I confirm that I will settle my tuition fees and provide evidence of personal identification and my qualifications, as and when requested by the University.

12. I am aware that failure to abide by sections 9 -11 above may result in my exclusion from the University in accordance with the Code of Student Behaviour and the Examination and Assessment Regulations, copies of which can be found, respectively, at

Please note this will apply for each academic year for the duration of your registration at the University. Should the Student Loans Company, an employer or sponsor refuse or fail to make any requested contribution to your fee, then you will be responsible for the full amount payable in respect of this registration.
